## The Analytical Document, the subgroups' experts continue their meetings

During September 2024 the Special Parliamentary Committee "On the deepening of reforms on Good Governance, Anti-Corruption and the Rule of Law for 2030 Albania in the European Union" continued work on drafting the Analytical Document/Analysis, which is being drafted by the High Level Experts' Group.

The main focus during September have been the meetings of the experts subgroups, divided according to the three pillars, which are the objective of the Special Committee's work: i) good governance; ii) anti-corruption; iii) the rule of law, for the process of identifying findings to draft the Analytical Document, based on the respective components.

The experts held several meetings, they worked together to discuss their findings and drafted initial analyses for each component, to then harmonize them within the respective pillar.

# Finalization of the methodology for coordinating international assistance

During September, the Special Parliamentary Committee, along with the heads of the HLE subgroups and the Technical Secretariat for each pillar, has worked also to finalize the methodology for coordinating international assistance, particularly the method of engaging external consultants, to make the best use of their professional expertise.

# Transparency of the SPC. The public communication platform and the website almost completed.

During this period, it was worked also on the public communication platform, dedicated to the work of the Special Parliamentary Committee, which will ensure full transparency of the committee's work by publishing all activities, decisions and documents produced throughout its mandate. The commission's website will enable the inclusion of every possible citizen and professional contribution in the improvement of the analysis, identification of measures to deepen this reform process and the legislative process in general. In the "Public Consultation" section, specific rubrics have been created to allow questions to experts or committee members, to conduct various surveys and to consult on legal issues and initiatives arising during the reform process.

#### The Chairman of the Special Committee held meetings with the ambassadors of France, Sweden and experts from the EU and US assistance missions and projects.

During September, the chairman and several members of the Special Committee on Good Governance, Anti-Corruption and the Rule of Law held meetings with important international representatives to inform them on the committee's work and objectives and to establish the necessary cooperation.

The ambassadors of France and Sweden confirmed their support to this initiative of the Parliament and to Albania's EU integration, emphasizing the importance of inclusiveness in the process and committing to provide contributions from their countries to specific areas of the project. Similarly, experts from EU and US assistance missions and projects, attached to the Special Committee, in separate meetings, commended the committee's approach and working methodology and they also discussed on the coordination of the monitoring and assistance they will provide.
